

TERMS AND CONDITIONS

The <u>Bahrain 200 – Tell us Your Story</u> competition is subject to the following terms and conditions.

1- By entering this competition entrants are deemed to accept these terms and conditions.

The Bahrain 200 – Tell Us Your Story competition is open to anyone currently living in Bahrain or the UK who:

- Is aged 16 or over
- Is a Bahraini or UK citizen or has lived in either country for over 5 years

 Is submitting original content which is privately owned by themselves or their family and has explicit written consent to submit this content to the Bahrain 200 – Tell Us Your Story competition.

The Competition Organiser reserves the right to require proof of eligibility.

- 2- Entries must be submitted by **one individual** and **only one prize** will be given to the winner.
- 3- This <u>Bahrain 200 Tell us Your Story</u> competition runs over three months: April, May, June 2016 and will close on June 6, 2016.
- 4- An entry is a submission of a personal Bahrain-UK story (this could be archival material, a photograph, a film, vlog, blog or e-mail or any other story format participants wish to share with us)
- 5- Entries must be submitted online using the online entry form here. Contact details and all other mandatory fields must be completed.
- 6- All entries must be submitted online by 00:00 GST (Gulf Summer Time) June 6, 2016, to the following e-mail address: <u>events.bh@britishcouncil.org.bh</u> with the subject title '#StillMates competition'
- 7- Entries received after the deadline will not be considered.
- 8- There are three sets of prizes on offer for winners: A Canon camera, the chance to exhibit their submission at the Bahrain National Museum as part of



the British Council's upcoming exhibition and VIP tickets to the British Council's upcoming Yazz Ahmad concert.

- 9- The British Council's decision on winning stories is final and no correspondence will be entered into.
- 10-Winning stories will be announced on the British Council's social media channels and winners will be notified by email only. All reasonable efforts will be made to contact the winners. If the winners cannot be contacted after all reasonable efforts the British Council will select the next best stories on the shortlist.
- 11-Prizes are not transferable and cannot be sold. The British Council reserves the right to substitute, in their reasonable discretion, any prize with a prize of equal value. No cash alternative will be offered for the prize.
- 12-By entering, any subsequent prize winners agree to allow, and consent to, British Council use of, and right to publish, entrant's name, photographs, images, all personal and other information (including general locations) for purposes of British Council publicity, promotional and news purposes (including use in printed publications, editorial and PR activities, on websites) related to this competition.
